RESOLUTION: LAWN CARE AGREEMENT

WHEREAS,

The Care of Cemeteries Act, PA 113 of 1915, MCL 128.61, *et seq.*, requires township boards to care for all cemeteries in the township except private cemeteries or those owned by cities or villages.

WHEREAS,

James Faber to provide mowing and trimming at the Washington Township Hall and at Collier Cemetery as a 1099-NEC; and

WHEREAS,

General Liability Insurance coverage is to be maintained by James Faber and proof of such is to be provided to Washington Township; and

WHEREAS,

Based upon a bid of \$3,000.00 for the 2025 mowing season, to be evaluated annually; and

WHEREAS,

The Township shall make monthly payments to James Faber for lawn care services in the months of June, July, August, September and October; and

WHEREAS,

The Township shall apply the service charges to Contracted Services under Building & Grounds in the chart of accounts.

NOW, THEREFORE, BE IT RESOLVED that

Washington Township agrees to enter into agreement with James Faber to provide our lawncare needs in 2025 and subsequent years if mutually agreed upon to extend the contract.




